<sup>\*</sup>Program volunteers shall not be required to obtain a federal criminal history report if individual has been a resident of Pennsylvania within the past 10 years and signs a 10-year Resident of Pennsylvania Affidavit in the presence of the principal or principal's designee affirming they have not perpetrated or been convicted of specific offenses. The 10-year Resident of Pennsylvania Affidavit will be signed on an annual basis. The clearances will need to be renewed every three years.

<sup>\*\*</sup>Program volunteers and Renters requiring TB testing are those who provide 10 hours or more per week in direct contact with children. The TB test must be administered within 3 months of volunteer activity and does not need to be renewed unless volunteer leaves the district and returns at a later time.

<sup>\*\*\*</sup>Casual volunteers will be required, on an annual basis, to sign the Casual Volunteer Affirmation in the presence of the principal or principal's designee affirming they have not perpetrated or been convicted of specific offenses.

<sup>\*\*\*\*&</sup>lt;u>Adult Education Instructors</u> without direct contact with children, will be required, on an annual basis, to sign an Adult Education Instructor Affidavit affirming they have not perpetrated or been convicted of specific offenses.
