STUDENT COUNCIL REPORTS

Student Council has recently sponsored a Halloween door decorating contest with a Red Ribbon theme that reminded students to remain substance free and National Children and Teens' Grief Awareness Month. Aaisha and Julia also reported on their trip to attend the Pennsylvania Association of Student Council's State Leadership Conference and thanked the Board for support of the trip. Highlights of the trip included a motivational speaker, student-led workshops, and a mini-thon, which JMS would like to incorporate into their school activities. Three spirit weeks are upcoming, as is a winter dance, student recognitions, and a potential fundraiser to benefit St. Jude Children's Hospital. Mt. Lebanon High School students Sara Frew and Doran Steinfeld presented a report to the Board. Doran Steinfeld and Sara Frew began their report by congratulating girls tennis WPIAL champions, girls soccer section champions, and cross country WPIAL champion Logan St. John Kletter. They also acknowledged participants in the fall play, Radium Girls, and Mrs. Majetic, Mr. Kuhar, and Mr. Stocklosa for a fantastic production. Halloween door decoration and spirit week festivities took place in October. Students are now preparing for the annual Holiday show, which will take place on December 7. Ticket sales will benefit the community. A food drive was also held, which donated over 1,350 non perishable goods and over \$200 to the Greater Pittsburgh Food Bank. SUPERINTENDENT'S REPORT

Dr. Steinhauer began by congratulating the high school Model UN Team for their accomplishments at the Model UN tournament held at the University of Pittsburgh. Next, the girls tennis team and cross country athlete Logan St. John Kletter were recognized for their athletic success during WPIAL championships.

Dr. Darby Copeland of Parkway West Career and Technology Center presented an update to the Board on happenings at PWCTC. Currently, 63 Mt. Lebanon students attend PWCTC and District students participating in National Occupational Competency Testing Institute assessments have achieved a 100% pass rate.
