### BOARD PRESIDENT'S REPORT

Mr. Wyland noted that due to weather conditions, it was necessary for everyone's safety to move the meeting to the Zoom webinar.

February is Black History Month which is an annual celebration of achievements by Black Americans and a time for recognizing the central role of African Americans in U.S. history. This year the elementary schools partnered with the high school group, Lebo Students for Curriculum Diversity, where older student will read stories to the younger students from Black authors and about Black history. The District strives to celebrate and teach history in a way that affirms the Black community. It is important to examine black literature, art, innovations and customs that have helped shape the culture of the United States and the world.

Mr. Wyland reported that Ms. Jackie Fulton, Markham Elementary librarian, was chose to be a member of the Leadership Institute for School Librarians. The grant for this year focused on Equity, Diversity and Inclusion, and provides professional development, training and strategic planning in EDI. Ms. Fulton was recognized for her work and commitment to providing equitable, diverse and inclusive school library programs for her students. Mr. Wyland congratulated Ms. Fulton on this professional recognition.

#### BOARD REPORTS

<u>Policy Committee</u> – Dr. Diamond reported that Policy Committee met on February 8, 2021, to discuss the adoption of one policy EFA, Food Services/Purchasing, and revisions to policies DIA, Federal Fiscal Compliance, DIAA, Conflict of Interest-Federal Programs, DIAB, Travel Reimbursement-Federal Programs, DJA, Purchasing Authority, and DJAA, Construction Contracts, Bidding and Awards. The Committee recommended moving the policies forward for Board approval.

<u>Diversity, Equity & Inclusion Committee</u> – Dr. Hackett reported that the Diversity, Equity & Inclusion Committee met before this evening's Regular Meeting and reviewed the DEI Task Force meeting held on February 3, 2021.

Mt. Lebanon Foundation for Education – Mrs. Cappucci reported that MLFE held a meeting on January 27, and they are looking at 2021 grants for teachers. Due to COVID, there was no fundraising last year or this year.

<u>Municipal Liaison</u> – Dr. Hackett reported that the new parking ordinance will be discussed at the next Commissioner's meeting. The bids for the Vibrant Uptown Project have gone out for bid.

<u>Parkway West</u> – Mr. Beal reported the Parkway West Career and Technology Center board met on February 2. The power motor sports program was presented to the education committee, and could start in the 2022-2023 school year. There is a need for small engine repair technicians.

There are currently 850 students in the hybrid mode, with 150 learning remotely. The school intends to start 4 days a week learning soon. The cosmetology space is being renovation. There are 100 students placed in that program.

Parkway will not be able to administer the NOCTII exams this year. Career completion exams will be held and recent graduates will be invited back to take the exams.

<u>Pathfinder School</u> – Ms. Fleisher reported that the Pathfinder Board met on January 20 where they held their reorganization meeting. Eric Kramer from Chartiers Valley was elected president, George Honchar from Carlyton was elected vice president, and Valerie Fleisher from Mt. Lebanon was elected secretary/treasurer. The board is developing a budget for next year, and the PRIDE program has been able to continue. The enrollment is 81 students from 26 districts.

<u>PSBA/NSBA</u> – Dr. Strotmeyer reported that the PSBA Advocacy Day will be a virtual event on March 22 and encouraged board members to register to attend. The annual NSBA conference will be held virtually April 8-10, 2021. Governor Wolf released his budget showing charter school reform and audits for charter schools.

# SUPERINTENDENT'S REPORT

At this time in the meeting, Dr. Steinhauer along with Dr. Davis and Dr. Irvin, presented an update on the CDC recommendations for returning to school and the updated Mt. Lebanon School District reopening plan.

It was moved by Fleisher and seconded by Strotmeyer that the Revised Reopening Education Plan dated February 15, 2021 is approved in substantially the form presented, subject to modifications deemed necessary by the Superintendent. (Copy in official minutes)

It was moved by Hackett and seconded by Strotmeyer that the Administration is authorized to implement the revised Secondary Education plan as recommended by the Superintendent, on March 1 or thereafter, so that students in grades 6-12 will have the option to remain in the original two day per week Secondary Instruction Schedule, to move to the four day per week Secondary (Enhanced) Instruction Schedule, or to elect available remote options, described in the Revised Reopening Education Plan adopted February 15, 2021, provided that the following conditions are verified prior to implementation:

- a. Allegheny County has announced community transmission rates that are in the Moderate or Low Range as defined by the Pennsylvania Department of Education for two consecutive weeks.
- b. Student desks will be placed to provide at least six feet of separation among students and staff to the maximum extent feasible, but in no event less than three feet, and barriers will be afforded to all students.
- c. Students will be spaced at least six feet apart while eating lunch.
- d. All teacher workstations/teaching spaces will have a distance of at least six feet from any student desk.
- e. The District will continue to comply with the Pennsylvania Department of Health's Updated Order Requiring Universal Face Coverings, and the Recommendations for Pre-K-12 Schools Following Identification of a Case(s) of COVID-19.
- f. The District will continue to comply with all mitigation measures described in the Health and Safety Plan.

Prior findings and approvals by the Board are only rescinded to the extent that they are inconsistent with this Resolution. The Superintendent continues to be authorized to alter the educational mode for any building, buildings or programs based on his determination that such change is warranted, including consideration of such factors as community spread, positive cases within the District, staffing, new directives and guidances, and other considerations, with prompt notification to the Board.

It was moved by Strotmeyer and seconded by Wyland that the Administration is authorized to implement the revised Elementary Education plan as recommended by the Superintendent, on March 1 or thereafter, so that students in Grades K-5 move to five day in-person instruction, or elect available remote options, as described in the Revised Reopening Education Plan adopted February 15, 2021, provided that the following conditions are verified prior to implementation:

- a. Allegheny County has announced community transmission rates that are in the Moderate or Low Range as defined by the Pennsylvania Department of Education for two consecutive weeks.
- b. Student desks will be placed to provide at least six feet of separation among students and staff to the maximum extent feasible, but in no event less than three feet, and barriers will be afforded to all students.
- c. Students will be spaced at least six feet apart while eating lunch.
- d. All teacher workstations/teaching spaces will have a distance of at least six feet from any student desk.

- e. The District will continue to comply with the Pennsylvania Department of Health's Updated Order Requiring Universal Face Coverings, and the Recommendations for Pre-K-12 Schools Following Identification of a Case(s) of COVID-19.
- f. The District will continue to comply with all mitigation measures described in the Health and Safety Plan.

Prior findings and approvals by the Board are only rescinded to the extent that they are inconsistent with this Resolution. The Superintendent continues to be authorized to alter the educational mode for any building, buildings or programs based on his determination that such change is warranted, including consideration of such factors as community spread, positive cases within the District, staffing, new directives and guidances, and other considerations, with prompt notification to the Board.
